

Item 1 – Introduction: Is an investment advisory account right for you?

Valiant Wealth, LLC is registered with the Securities and Exchange Commission as an investment adviser. Please be aware that brokerage and investment advisory services and fees differ and it is important for you to understand the differences. Free and simple tools are available to research firms and financial professionals at [Investor.gov/CRS](https://investor.gov/CRS), which also provides educational materials about broker-dealers, investment advisers, and investing.

Item 2 – What investment services and advice can you provide me?

We offer investment advisory services to retail investors. Our principal services include financial planning and portfolio management. As part of our standard portfolio management service we provide continuous and regular supervisory and/or management services with respect to your account(s). We do not monitor the investments made as a result of a financial plan unless you have hired us for portfolio management services. Our portfolio management services are offered on either a *discretionary* or *non-discretionary* basis. *Discretionary* authorization allows us to determine the specific securities, and the amount of securities, to be purchased or sold for your account without your approval prior to each transaction. *Non-discretionary* arrangements require us to obtain your approval prior to executing any transactions on behalf of your account. We do not limit our advice to proprietary products, or a limited menu of products or types of investments. In general, we require a minimum of \$100,000 to establish a relationship with us. At our discretion, we reserve the right to waive this minimum.

Item 3 – What fees will I pay?

We are primarily compensated by a percentage of assets under our management and fixed fees. Our fees vary depending on the services you receive. Portfolio management fees are based upon a percentage of your assets under our management, and are payable each quarter in arrears. The more assets there are in your advisory account, the more you will pay in fees. Therefore, we have an incentive to encourage you to increase the assets in your account. We can negotiate performance-based fee arrangements with “Qualified clients” who have a net worth greater than \$2,100,000 or those for whom we manage a minimum of \$1,000,000. These fees are paid annually in arrears, unless otherwise negotiated. Performance based fee arrangements create an incentive to recommend riskier or more speculative investments to generate higher investment returns. Side-by-side management of accounts paying performance-based fees with those that do not, creates a potential conflict for us to favor accounts for which we receive performance-based fees. We provide financial planning services for a fixed fee. Our fees are negotiable depending upon the complexity and scope of the service, your financial situation, and your objectives.

Description of Other Fees and Costs: The fees that you pay to our firm for investment advisory services are separate and distinct from the fees and expenses charged by investment companies (e.g., mutual funds, exchange traded funds, unit investment trusts and variable annuities). These fees are described in each fund’s prospectus. These fees will generally include a management fee and other fund expenses. You will also incur transaction charges and/or brokerage fees when purchasing or selling securities. These charges and fees are typically imposed by the broker-dealer or custodian that executes the trade. The broker-dealer or custodian may also charge your account for custodial fees, retirement account fees, trust fees, exchange fees, redemption fees that may be assessed on investment company shares, transfer fees, account termination fees or other special service fees and charges. We do not share in any portion of these fees imposed by the broker-dealer or custodian. To fully understand the total cost you will incur, you should review all the fees charged by investment companies, broker-dealers, our firm, and others.

You will pay fees and costs whether you make or lose money on your investments. Fees and costs will reduce any amount of money you make on your investments over time. Please make sure you understand what fees and costs you are paying.

- ❖ *Help me understand how these fees and costs might affect my investments. If I give you \$10,000 to invest, how much will go to fees and costs, and how much will be invested for me?*

What are your legal obligations to me when acting as my investment adviser? How else does your firm make money and what conflicts of interest do you have?

When we act as your investment adviser, we have to act in your best interest and not put our interest ahead of yours. At the same time, the way we make money creates some conflicts with your interests. You should understand and ask us about these conflicts because they can affect the investment advice we provide you. Here are some example(s) to help you understand what this means:

- All investment advisers face conflicts of interest, which are inherent in the business. Our primary source of compensation is through asset based fees. Therefore, we are incentivized to acquire new clients and to increase assets under management. Other conflicts of interest result from other business activities we engage in and relationships we have with business partners and third parties, or relationships we have established with other financial institutions.
- We are affiliated through common control of various entities that offer private placement interests that we may recommend to you. If you invest in these private placements, we will receive management fees and/or performance-based fees in connection with these interests. This creates a conflict of interest because we have an incentive to recommend these private placements over other investments. While our firm is accountable to you as a fiduciary and, consequently, must exercise good faith and integrity in handling both your and the entities' business, you should be aware of the potential for conflicts of interest. Investors in the private placements should refer to the offering documents of the respective entity for detailed disclosures. We will not charge you an additional asset management fee for the portion of your portfolio that is invested in the private placement(s).

How do your financial professionals make money?

Our financial professionals receive salary based compensation, a percentage of advisory billings and/or bonuses based on the amount of client assets they bring to our firm. Therefore, our financial professionals have an incentive to encourage you to increase the assets in your account. Additionally, our firm's Principal is the manager of several entities that offer private placements that you may be solicited to invest in. This creates a conflict of interest because this individual will receive additional compensation as manager of these entities and the private placements that you invest in. You are not required to purchase interests in these private placements from any of our financial professionals.

Material Changes to Form CRS – Client Relationship Summary

The purpose of this appendix is to inform you of any material changes since the previous version of this Form CRS dated **June 26, 2020**.

On **September 21, 2020**, we updated our Form CRS to add the following clarifications to Item 3 regarding fees and conflicts of interest:

- We can negotiate performance-based fee arrangements with “Qualified clients” who have a net worth greater than \$2,100,000 or those for whom we manage a minimum of \$1,000,000. These fees are paid annually in arrears, unless otherwise negotiated. Performance based fee arrangements create an incentive to recommend riskier or more speculative investments to generate higher investment returns. **Side-by-side management of accounts paying performance-based fees with those that do not, creates a potential conflict for us to favor accounts for which we receive performance-based fees.**
